

# Bicycle Locker Renewal Lease Agreement



## Bicycle storage only.

**This agreement limits our liability – read it carefully.  
Lockers are assigned on a first come first serve basis.**

1. This agreement is for renewal purposes only. Initiation of bike locker lease requires the customer to go in person to the Downtown Boulder Station, Boulder Junction at Depot Square, Civic Center Station, Denver Union Station or Denver International Airport to submit the Initial Bicycle Locker Lease Agreement as well as a valid form of identification.
2. The undersigned must have an existing Initial Bicycle Locker Lease Agreement and is bound by the terms and conditions as outlined in said agreement on file at the RTD offices.
3. This agreement entitles the renter to store one bicycle in the designated locker for an additional 6 (six) month period from the month the Renewal Lease Agreement is signed or the month the Renewal Agreement is received by RTD, whichever is first.
4. Each time a customer's contract expires (every 6 months) he/she must update the information in the agreement, re-sign the agreement and pay a renewal fee. The customer may report in person to the Downtown Boulder Station, Boulder Junction at Depot Square, Civic Center Station, Denver Union Station or Denver International Airport to renew the agreement or the customer may send the signed renewal forms and renewal fee via US mail to the address listed below. Renewal forms may be obtained on the RTD website ([www.rtd-denver.com](http://www.rtd-denver.com)). This must be done within 14 days of the expiration month or the customer will forfeit their rights to a locker.
5. If RTD does not have a renewal agreement on file by the 15th of the month following the expiration month, RTD will remove the customer lock and any items found in the locker will be disposed of without further notice.
6. RTD reserves the right to make changes to the bike locker program at any time. Notice of such changes will only be posted on the RTD website ([www.rtd-denver.com](http://www.rtd-denver.com)).
7. This constitutes the entire agreement and execution of it constitutes acknowledgement by the lessee that the lessee has read and agrees to the foregoing. The person signing this agreement must be 18 years of age or older.  
**All fees are non-refundable.**
