TERMS

Your date becomes reserved only when this "Contract" is drawn up, signed and a \$100.00 booking deposit is received. Please be sure that you initial where indicated to acknowledge that you understand the policies of each topic.

DEPOSIT:

There is a 100.00 booking deposit paid to reserve your date. In the event of cancellation, your deposit is NON-REFUNDABLE. _____

DOWN PAYMENT:

In addition to the deposit, a 50% down payment is expected 2 months prior to the event date. If this contract is signed within two months of event date, 50% is due upon signing. _____

FINAL PAYMENT:

Total contract price is due one month prior to your event date. The cake(s) will not be made if the final payment has not been received. _____

CHANGES:

Changes to your cake size, description, flavors, etc. will be accepted until one month prior to the event date. After that lockout date we cannot accept any changes. Changes may affect the price of the cakes. _____

COLOR DISCLAIMER

The colors PINK, BLUE, PURPLE, BLACK or any shade of these colors cannot be guaranteed. These colors are unstable and tend to fade and/or bleed into surrounding colors and frostings when exposed to differing weather, sunlight, heat, humidity, moisture, etc. There is also no guarantee for outdoor events but we will give these colors our best efforts.

OUTDOOR EVENTS AND WEATHER

Sweet Delights Cakery is NOT responsible for any weather damage to products after the customer has taken possession. We provide insight and guidelines to avoid adverse effects of various weather conditions as follows: _____

HEAT: Buttercream/Whipped Cream/Fresh Fruit cakes can melt and therefore are not recommended for outdoor events in temperatures exceeding 80 degrees (which are common in the months of May to September or October). _____

HUMIDITY: Fondant/Gum paste cakes do not do well in humidity, they can melt and/or bubble. _____

WIND: Can push product over no matter how small or big. It may blow debris or bugs into your cake and or other desserts. _____

RAIN: Fondant can be spotted by rain. Rain can change or melt colors or product structure. _____

DELIVERY & SETUP:

Delivery is free within a five mile radius of Sweet Delights Cakery. If you need delivery outside of 5 mile radius the fee is \$1.00 per mile roundtrip (RT). This delivery fee is a separate charge and will not be included in the price of your order. You need to pay this fee when the final payment is made. The setup fee is \$30. After set-up at your event is complete, Sweet Delights Cakery will not be responsible for any mishandling of your cake/cupcakes, including but not limited to: bumping, temperature, scraping, touching, moving, etc. _____

FRESH FLOWERS:

If fresh flowers are to go on the cake(s), it is the responsibility of the florist to apply the flowers. It is also the customer's responsibility to check with their florist to see which flowers can and cannot touch icing or cake that individuals will consume. _____

PICKING UP YOUR ORDER:

If you pick-up your order, you should make sure that you have a clean, flat surface to set cake(s) on while driving. Most of our cakes are either too large or irregularly shaped to fit in a cake box so you need to take special care to protect them. Once you leave with the order it is no longer the responsibility of Sweet Delights Cakery. _____

CANCELLATION POLICY:

Orders cancelled prior to the one month lockout date will be refunded minus the \$100.00 non-refundable booking deposit. Orders cancelled after the one month day lockout date will NOT be refunded. In the event that something occurs to affect your scheduled event date please contact us to discuss options. _____
