NOTES FOR COMPLETING FORM 405 APPLICATION TO AMEND OR CANCEL A POLICE BANNING NOTICE

Under the *Police Powers and Responsibilities Act 2000* a respondent for a police banning notice may apply to the commissioner to amend or cancel a police banning notice. The application must be made on this approved form and contain sufficient information to enable the commissioner to make a decision. Failure to use the approved form or provide sufficient information may result in your application not being processed.

A respondent for a police banning notice may apply to amend or cancel a police banning notice on any grounds, including (but not limited to):

- That the police banning notice prevents you from entering, remaining in, or using a mode of transport to travel to, your residence, place of employment or place of education
- That the police banning notice is causing, or will cause, undue hardship to you or a member of your family

The following is an outline of the type of information required. It may be necessary to attach other documents as evidence of the claims you make in your application.

GROUND FOR APPLICATION

That the police banning notice prevents you from entering, remaining in, or using a mode of transport to travel to, your residence, place of employment or place of education.

TYPE OF INFORMATION REQUIRED:

You will need to provide information that outlines how a refusal to grant your application to amend or cancel the police banning notice would prevent you from entering or remaining in, or using a mode of transport to travel to, your residence, place of employment or place of education.

This statement should include information regarding:

Residence details (if applicable)

- Your place of residence
- Details of travel or transport routes affected by the police banning notice
- How does the police banning notice prevent you from entering or remaining in, or using a mode of transport to travel to, your residence
- Why you required the police banning notice to be amended or cancelled
- What would be the impact if the police banning notice was not amended or cancelled
- Any other relevant information

Employment details (if applicable)

- Your occupation
- Details of current place of employment – including employer and address, regularity (full time/part-time/casual)
- The work you perform
- What hours and days do you normally work
- How long you have been in this position
- How does the police banning notice prevent you from entering or remaining in, or using a mode of transport to travel to, your place of employment
- Details of travel routes between your residence and place of employment
- Why you required police banning notice to be amended or cancelled
- What would be the impact if the police banning notice was not amended or cancelled
- Any other relevant information

Education details (if applicable)

- Details of current place of education – including education provider and address, regularity (full time/part-time/casual)
- Your course of study
- What hours and days do you normally study
- How long is your current course of study with your education provider
- How does the police banning notice prevent you from entering or remaining in, or using a mode of transport to travel to, your place of education
- Details of travel routes between your residence and place of education
- Why you required the police banning notice to be amended or cancelled
- What would be the impact if the police banning notice was not amended or cancelled
- Any other relevant information

Statement from your employer or education provider: Where applicable, your application may not be processed if you fail to provide evidence of your current place of residence or a statement from your employer (unless self-employed) or education provider.

Note: Any available documents supporting the accuracy of the claims in your statement should be provided.

The police banning notice is causing, or will cause, undue hardship to you or a member of your family.

TYPE OF INFORMATION REQUIRED:

You will need to provide information that outlines how a refusal to grant your application to amend or cancel the police banning notice is causing, or will cause, undue hardship to you or a member of your family.

This statement should include information regarding:

- How the police banning notice is causing, or will cause, undue hardship to you or a member of your family
- Why you require the police banning notice to be amended or cancelled
- What would be the impact if the police banning notice was not amended or cancelled
- Any other relevant information

Note: Any available documents supporting the accuracy of the claims in your statement should also be provided.

- The grounds for your seeking to have the police banning notice amended or cancelled

- Any other relevant information

Note: Any available documents supporting the accuracy of the claims in your statement should also be provided.
