Equipment must be purchased between Jan. 1, 2016, and Dec. 31, 2016. Equipment must be installed and operating prior to submission of final rebate application.

Rebate application must be submitted within six months of dealer invoice for the equipment/material purchased. The rebate will be based on the rebate schedule in effect on the date of dealer invoice for the equipment/material purchased. Rebate applications received after six months of dealer invoice will not be eligible for rebates.

- Transportation gas customers with daily metering are ineligible for natural gas incentives. However, customers with monthly metering under the Monthly Metered Transportation Service natural gas tariff are eligible for energy incentives.
- Rebates cannot exceed 70 percent of the installed cost (materials and reasonable labor). Customers receive the lesser of the rebate amount or 70 percent of installed cost.
