Tips

- Listing only one preference does not increase your chance of getting into that school.
- Have at least one school as a “safety net” where you are likely to be offered a place.
- You are advised to **include your catchment school** as one of your three preferences. However, please note that you are not guaranteed a place at your catchment school.
- You should list the schools **in the order that you would most prefer them**, not the order you think you might get them.
- Many schools have more applications than there are places available. To decide which children to offer places to, a set of admission criteria is used.
- Different schools have different criteria so it is important that you check the admission arrangements for all the schools you are interested in. For more information, please see **www.bedford.gov.uk/secondarytransfers**
- Applying for more than one school does not weaken your chances of getting a place at your preferred school.
- **Please make the time to visit schools before you apply so that you have all the information you need.**
