**Client agrees:**

1. This release of liability agreement applies to Organization, its agents, officers, directors, principles, employees, volunteers, invitees, independent contractors, insurers, and to any owners, agents, officers, directors, principles, employees, volunteers, customers, clients, operators, related to any premise, venue, or facility through which Organization provides services to Client.
2. This release of liability agreement applies to claims by myself, my heirs, assigns, personal representatives and estate, and any minor person(s) participating in any way in the services provided by Organization over whom I have legal custody, guardianship, or parental responsibility.
3. I acknowledge that I, and any child(ren) over whom I have custodial, guardianship, or parental responsibility, voluntarily choose to participate in the activities sponsored for us by Organization, which activities may include both known and unknown inherent risks of physical, mental, and emotional injury, deriving from (but not limited to) equipment malfunctions, building malfunctions, lack of supervision, lack of proper equipment or padding, netting, or other safety measures, slipping, falling, colliding with fixed objects or with people, as well as negligent acts committed by me, my child(ren), the Organization, or the premises, facility, or venue at which services are provided to me by Organization.
4. In spite of the known and unknown risks, I freely choose for myself and/or my child(ren) to participate in the activities sponsored by the Organization, and I hereby expressly and voluntarily remise, release, acquit, satisfy, and forever discharge Organization (and the persons and entities described in Paragraph 1 above), and agree to hold it and them harmless of and from all manner of actions, causes of action, claims, suits, debts, dues, sums of money, accounts, damages, judgments, and demands, arising in law or in equity, whether the action or claim arises out of any damage, loss, personal injury, or death to me or my child(ren) in connection with participation in the activities sponsored by the Organization. This release of liability is effective, valid, and binding regardless of whether the damage, injury, loss, or death is caused in whole or in part by any act or omission on the part of Organization.
5. I hereby grant Organization the irrevocable right and permission to photograph and/or record myself and/or my child at this party, and to use and publish the photographs and/or recordings (and all images, likenesses, and sounds of me and/or my child(ren) contained therein) for all purposes including advertising, promotions, and fundraising, in any manner and media now known or hereafter devised (including without limitation, on Organization's website, in print brochures, in television or newspaper advertisements or news stories, and on display at public functions and fundraisers), in perpetuity throughout the world, and including the right to alter or modify the images, likenesses, and sounds captured in the photographs and/or recordings, whether visual, audio, or audio-visual. I further grant to Organization the right to use my name and the name of my child(ren) in connection with our images, voices, or likenesses depicted in the photographs and/or recordings captured at this party. I understand that I will not be given the opportunity to inspect or approve the finished products or the advertising copy or the printed matter that may be used in connection therewith. In granting this right to Organization, I am fully and without limitation releasing it from any liability that may arise from use of the images.
