The Bidder agrees to commence and complete the Work of the Contract Documents to Substantial Completion within the dates specified above.

The Bidder also agrees to pay as liquidated damages, the sum of \$500.00 for each consecutive calendar day after Project Duration that project has not obtained Substantial Completion..

The Bidder has carefully examined the Contract Documents, the site and all other conditions affecting the cost of the work for constructing this project in accordance with the Contract Documents and hereby proposes to furnish all labor, materials, supplies and services for the proposal sums stated below.

The proposal sums indicated below cover all expenses incurred in performing and completing the work required under the Contract Documents of which this proposal is a part.
