

***Happy Apple Photography* Wedding Photography Event Agreement and Photograph Copyright Release Form**

EVENT #-

A. I _____ (CUSTOMER) own the copyrights to photos specified in section C. I understand that I must give credit to PHOTOGRAPHER AND STUDIO (Name is listed below in Section D) when photos are presented publicly in any fashion, online or otherwise.

B. Photography Packages, Pricing and Agreement Guidelines:

*CUSTOMER must initial the package they desire.

- * **Small Reception:** located at a bar or restaurant; could have up to 100 people attending; no traditional activities (bouquet toss, garter removal/toss, dancing/disc jockey). May contain cake cutting ceremony and speeches.
- * **Large Reception:** located at large event venue, hall, or ballroom; could have over 100 people attending; traditional activities (bouquet toss, garter removal/toss, dancing/dj). May contain cake cutting ceremony and speeches.
- * Choice between whether the CUSTOMER's **Reception** falling under **Large** or **Small** is at the discretion of the PHOTOGRAPHER.

1. After the event, photographs will go through a quality control process to insure the best product for the CUSTOMER. Quality Control includes basic editing and enhancing of photos as well as deleting of photos that are out of focus, over or underexposed, poorly composed, or poorly framed. After quality control, PHOTOGRAPHER agrees to follow the above chosen guidelines initialed by CUSTOMER based on Photography package and price point.

2. After the date of the signing of this agreement, CUSTOMER has 3 weeks to pay 50% of the price for the package initialed above in order to guarantee the date of your event saved for CUSTOMER. Date is subject to loss if payment is not received on time.

3. The following will be known as the EXCHANGE: After photos are ready, CUSTOMER agrees to have the remaining 50% of the total, after Customer agrees no changes are to be made to any of the finished photos. The CUSTOMER will then receive a Flash Drive, of appropriate size, from the PHOTOGRAPHER containing all the photos that have gone through the quality control process. This EXCHANGE can be done differently at the CUSTOMER's request. Options like, file sharing sites (such as Dropbox, Evernote, etc...), and mailing through the United States Postal Service are also available for the aforementioned EXCHANGE. Prints, Custom Framing, and Complete Photo Albums will cost extra and will be decided with a separate agreement.

1. Customer will own the copyrights to all photos guaranteed based on package initialed above in section B. Customer must initial in agreement to allow PHOTOGRAPHER right to use all photos how PHOTOGRAPHER sees fit. That includes: re-editing in any way PHOTOGRAPHER sees fit; using them in all promotional, advertising and marketing means the PHOTOGRAPHER uses; as well as applying them to PHOTOGRAPHER's website and social networking sites.
