

## ENLISTMENT PARENT/ GUARDIAN CONSENT FORM

### How to complete this form

Please read the following rules very carefully.

- a) If the candidate lives with both parents they both must sign.
- b) If the candidate lives with only one parent, then just their signature is sufficient.
- c) If the candidate doesn't live with either parent, the signature required is that of any person (whether or not a parent of the candidate) who has parental rights and powers in respect of the candidate and whose whereabouts are known, or can after reasonable enquiry be located.
- d) If after reasonable enquiry no such person as mentioned in c above can be traced, the signature required is that of any person in whose care (whether in law or in fact) the candidate is.
- e) If the candidate is the subject of a Supervision Order, a person authorised by the supervising authority must also sign. The date the Order expires must also be given.
- f) If the candidate is the subject of a Care Order, the only signature required is that of a person authorised by the Local Authority concerned.
- g) The person acting as witness to the signatures on this form should be someone of standing in the community. Such persons should normally be one of the following:  
  
Justice of the Peace, Clergyman, Officer, Warrant Officer or Senior NCO of HM Forces (serving or retired), Civil Servant or Local Government Official (established), Policeman, Doctor, Teacher, Barrister, Solicitor, Postmaster or Sub-Postmaster, Bank Official, Trades Union Official, Local Authority Councillor, Business Owner or Executive.
- h) A witness must **not** be related to the person offering to enlist **or** to the person(s) consenting to the enlistment.
- i) If required, staff at an Army Careers Centre (ACC) can act as witness to the signature(s).
