Official Rules

NO PURCHASE NECESSARY TO ENTER

Eligibility: To enter the Just Drive for Education Sweepstakes ("Sweepstakes"), individuals must satisfy the following requirements as of the end of the Sweepstakes Period (as defined below) (the "Eligibility Requirements"):
