



SNEAKER HABIT

CONSIGNMENT AGREEMENT

Pricing. SNEAKER HABIT will make every effort to obtain the highest reasonable price for the items and, in any event, will accept no less than the minimum price set forth in the agreement attached without approval by Consignor. SNEAKER HABIT does not guarantee your items will sell whether expressed or implied.

SNEAKER HABIT sets appropriate prices on items based upon a combination of experience, knowledge of market trends, current resale values, the demand for the item, and its condition. SNEAKER HABIT retains the right to accept or decline any item for consignment at their sole discretion.

Percentage of Commission. SNEAKER HABIT will be entitled to retain a percentage of the sale price for all goods sold pursuant to this agreement. Our terms are a percentage of the sale based on the actual price when sold. You, the Consignor will receive 85% of the selling price. _____ (initials)

Advertise. SNEAKER HABIT agrees to advertise item(s) and use other alternative marketing promotions to sell said items. SNEAKER HABIT further retains the right to advertise items for sale as they see fit.

Condition of Items. SNEAKER HABIT will only sell, buy or trade items that are authentic, clean, and in excellent condition. Any defects should be brought to our attention upon presentation. If defects are discovered after an item has been consigned, SNEAKER HABIT may reduce price of item for a quick sale or return the item to the Consignor.

Payment. Consignor can collect payment after the 15th of each month for the previous month. If the Consignor chooses to keep money on account to use at SNEAKER HABIT in lieu of receiving payment, they will be given an additional 10% commission on their items sold (totaling 80%).

Monies not collected within one year of activity are forfeited to SNEAKER HABIT and inactive accounts closed.

The Consignor is responsible for retrieving payment for items sold. All checks will be mailed to Consignor. Checks will be marked void after 120 days.

Consignment Period. There is a one-time non-refundable \$10 consignment fee. The consignment period is for sixty (60) days. _____ (initial)

If your consignment period ends with no sale, Consignor must contact SNEAKER HABIT within fourteen (14) days to be reclaimed or to renew for another consignment period. Consigned items not retrieved after the expiration of their 60-day contract and the passage of the 14-day grace period may become the property of SNEAKER HABIT.

Reclaiming your item. You MAY NOT reclaim any item before the end of your consignment period without penalty. The penalty is a flat \$20.00. This is for our time and marketing efforts in taking your item in on consignment. _____ (initial)

SNEAKER HABIT does not telephone Consignors regarding their accounts. **It is the responsibility of the Consignor to monitor the expiration date of your consignment** items as SNEAKER HABIT does not have the resources to guarantee reminder calls.

Liability. If any item provided to SNEAKER HABIT for resale by the Consignor is found to be counterfeit or SNEAKER HABIT incurs any liability as a result of the sale of such an item, the Consignor agrees to indemnify SNEAKER HABIT for any damages including any theft, and all judgments, liens, fines, etc. _____ (initial)

| DS | DEADSTOCK – Never been worn or tried on; in perfect mint condition – no scuffs, stains, or scratches; factory laces and contains all original contents. |
| VVVNDS | Has been tried on, but never touched cement or been worn outside; closest form of a near mint condition sneaker – no scratches, scuffs, or stains; no heel cracking or sole separation; contains all original contents. |
| VVNDS | Worn no more than 1-2 times; in good condition – no visible creasing; no scratches, scuffs, or stains; no heel cracking or sole separation; contains all original contents. |
| VNDS | Worn no more than 2-4 times; in good condition – very light to no creasing, no scratches, scuffs, or stains; no heel cracking or sole separation; contains all original contents. |
| NDS | Worn a handful of times; in fair condition – light to very light creasing, minor scuffs, minor scratches, no stains; no heel cracking or sole separation; contains all original contents. |
