

Student Transportation Agreement

This agreement amends the 2015-2016 Policies and Fees Agreement between Sparhawk School, Inc. and the undersigned, Parent(s) or other legally responsible person for the Sparhawk student identified herein (the "Student"). Student Name: _____

During the student school year 2015-2016, Sparhawk will arrange for bus transportation services to and from Sparhawk School grounds for such Student. The services will include previously identified pickup and drop-off places at identified ranges of times.

Cost and Payment:

Option 1: Round trip: The cost for the services shall be \$3,600.00 for the school year. Payment may be made in full by check payable to Sparhawk School, Inc. upon remittance of this form or in ten equal monthly installments of \$360.00 commencing on September 1, 2015 and nine successive payments payable before the 1st day of the month commencing in October 1, 2015 and ending June 1, 2016.

Option 2: One way for either the AM or PM route: The cost for these services shall be \$2,000.00 for the school year. Payment may be made in full by check payable to Sparhawk School, Inc. upon remittance of this form or in ten equal monthly installments of \$200.00 commencing on September 1, 2015 and nine successive payments payable before the 1st day of the month commencing in October 1, 2015 and ending June 1, 2016. This option offers an additional benefit at \$15.00 per ride for the route not chosen. This is only for families that have an annual transportation contract.

Except as otherwise stated in this Addendum, all of the other terms and conditions in the 2015-2016 Policies & Fees Agreement, including without limitation, the Policy For Non-Payment and Dismissal or Discharge section, are incorporated herein, remain in force and are not affected hereby.

Release

The undersigned acknowledge and agree that transportation of the student may involve risks from, without limitation, automotive, bus, other vehicles, road and weather conditions, contagious illness, actions of governments, groups or individuals and that the student could suffer physical injury, or death resulting from the action, non-action or negligence of another person, or from the student's own action, non-action or negligence.

The undersigned acknowledge and agree that any contractor of Sparhawk shall not be deemed to be acting as employee or agent of Sparhawk while the student is being transported under the care, custody or control of the –such contractor.

In consideration for receiving the transportation services, the undersigned hereby agree to (i) release, discharge and covenant not to sue Sparhawk School, Inc., it's subsidiaries and related legal entities, it's officers, directors, shareholders, agents, employees and representatives, their heirs, executors, administrators, successors and assigns (collectively the "Sparhawk parties"), from and for any and all causes of action, rights, loss, injury, damages, liability, claims, costs or expenses suffered or incurred directly or indirectly by the undersigned or the Student as a result of such transportation or this agreement (collectively "Claims and Losses"), and (ii) indemnify and hold harmless the Sparhawk parties with respect to any Claims or Losses by the Student or any third parties ,including reasonable court costs and attorney, accounting and expert witness fees incurred by it.

The undersigned have read and fully understand the terms and conditions of this Student Transportation Agreement and the signature(s) below indicate my/our agreement to be legally bound thereby.
