*I / We hereby agree:*

- a) To pay the charges for such supply from time to time published by the Company pursuant to Section 73 of the Electric Power Act.*
- b) That the provisions of and conditions contained in the Supply Contract and Conditions (EAP&L) Byelaws 1953 as amended from time to time shall be the basis of and form part of my/our contract with the Company.*
- c) To allow authorised K.P.L.C. personnel entry into the premises of supply for purposes of reading the meter, and inspecting the installation to ascertain that the same is in a good working order.*
- d) To avoid any kind of meter damage and/or meter tampering so as to avoid unauthorised/fraudulent use of electricity.*

*The maximum demand of this supply will not exceed the KVA stated in the item AMD (KVA) without the written consent of the Company.*

*The methods of charge are specified in Methods of Charge (K.P.L.C) Byelaws 19..... as amended from time to time or in any Byelaws substituted therefore, and the prices are published in the Company's Schedule of "Prices for Electrical Supplies in Kenya".*

### **REFERENCES :**

**1. Contract Expiry Date.** - For those contracts defined as Permanent the expiry date is the date when the contract is cancelled. It is not applicable to any other type of contract.

**2. P.I.N.-** Personal Identification Number.

**3. Vertical Code.** - Is the combination of: floor No., stair No. and door No.

**4. Voltage.** - Is the expected voltage calculated by K.P.L.C according to the Enquiry for Supply of Electricity and inspections carried out at the property.

**5. Connection type.** - Is the connection type to be used for supplying electricity. This is determined by the K.P.L.C. according to the Enquiry for Supply of Electricity and studies carried out by K.P.L.C. technical staff.
