DOLLARS FOR DOERS PROGRAM GUIDELINES

HOW TO PARTICIPATE

All employees and retirees of Upper Peninsula Power Company are eligible to participate. Volunteer and keep track of your time between January 1 and December 31 each year. Then, simply complete, sign and submit the Volunteer Program Tracking Form and Grant Application to the program coordinator by December 31. Time volunteering with a non-profit organization outside a 501(c)(3) agency will count, as long as the organization is located in areas served by UPPCO. Volunteerism for political or evangelical causes does not. Be sure that the organization you wish to receive your grant is an "eligible organization" (as noted below).

ELIGIBLE ORGANIZATIONS

If you volunteer for organizations in the categories below, they may be eligible for *Dollars for Doers* funds. *Eligible organizations for funds are only those that operate in the UPPCO service area.* They must also be tax-exempt under Section 501(c)(3) of the Internal Revenue Code.

- Arts and culture
- Community and neighborhood development
- Human services and health
- Environment
- Education

INELIGIBLE ORGANIZATIONS

- Civic groups, including fraternal, social or union
- Religious or political organizations
- Organizations whose philosophy and mission conflict with company positions
- Educational institutions (schools, universities) without 501(c)(3) status
