

CONSIGNMENT SALE PARTICIPANT AGREEMENT FORM

- The registration fee is \$12.00, which includes 100 tags.
- Extra tags are \$2.00 for 100 or \$1.00 for 50. (Additional tags are available in the school office.)
- Working a minimum of **three** hours is a requirement to participate in the sale. If you can't work, an adult 18 years or older may work in your place.
- You will receive a check of 70% of your sales within **three** weeks of the sale. If you would like your check mailed, please turn in a stamped, self-addressed envelope.
- There are no provisions for babysitting during the sale. Under no circumstances are you allowed to bring your child to work with you. Thank you in advance for your understanding.
- Chilhowee Hills and Freedom Christian Academy are not liable for personal accidents of any kind or lost, stolen, or missing items.
- **Please fill out both portions of your tags completely so proper credit can be given when an item sells.**
- **If you do not want your merchandise to be half price on Saturday, you must place a red dot to the right of the price on both parts of the sales tag. If you place the red dot on any other part of your tag it might be sold at the reduced rate of 50% off.**
- **Due to space limitations, we can no longer include stuffed animals in the sale.**
- All items being sold must be in good condition. We will not sell any stained, torn, or broken items. **Clothing being sold must be in the current season (for example, bathing suits for the spring sale and sweaters during the fall sale) and fall within the categories of the sale (infant thru teen clothes only and other items related to children). If we find out of season clothing or inappropriate items, they will not be sold, and will be returned to you on Saturday.**
- Clothing must be hung on hangers with the curve of the hanger pointing to the left (like a question mark). Please label and bundle clothing by size and gender with a rubber band to make the drop off process easier.
- **Drop off times are Wednesday, September 9th 6:30-8:00pm and Thursday, September 10th from 8:30a.m.-12:00 p.m.** Please allow time to distribute your items into the designated areas at drop off.
- Pick up time on Saturday, September 12th is from 2:15 p.m. -2:55 p.m. **(please do not be late)** for all unsold items that are not donated. If your items are not picked up by 3:00 p.m. the items will be donated. **We cannot hold your items to pick up at a later time.**
- If for any reason you are not able to participate in the sale after you registered please call the office as soon as possible. Fees are not refundable but may be used for the next sale.
- **Your registration fee and consignor agreement form must be turned in before your items can be placed on the sales floor.**

Important Safety Information from the U.S. Consumer Product Safety Commission:

Due to possible deadly safety concerns, we are not allowed to knowingly resale certain items. Please refer to all details on the commission's website: www.cpsc.gov/resale. Due to this, by signing this agreement, you agree to not submit or try to sell any of the following products known to be safety hazards:

Any product containing lead over specified safe amounts; any crib manufactured before June 28, 2011; any bath seat manufactured before December 6, 2010; any bean bag chair with a zipper, any tears, or with any stuffing coming out; any bunk bed without proper warning stickers or without proper side rails; **any car seat, booster car seat, or carrier**; any halogen lamp; any hair dryer not properly polarized; any mattress manufactured before July 1, 2007; any toys with known phthalates; any mesh-sided play yard not in proper working order; items with small parts that are not properly labeled for safety; any toy chest or trunk with an automatic locking device or latch; any toy with magnets not properly labeled for safety; or any baby walker without gripping strips underneath or less than 36" wide.
