Complete this document at the time of sale. You may also need it for title and registration. Use our Purchase Agreement document if there are things that must be done (such as survey or financing) before you will accept the boat.

## TITLING AND REGISTERING YOUR BOAT

**TITLE AND REGISTRATION:** The information on the title for the boat should match the registration and the owner's name. Look on the title to see if any liens have been released. Some states require titles for trailers too.

**CHECK THE HULL IDENTIFICATION NUMBER (HIN):** It must match the title and registration or the boat may not be able to be registered.

**BILL OF SALE:** Fill this form out completely. Make sure the seller's name and the boat's HIN is exactly as it appears on the title.

**PAYMENT:** Cash is okay for small amounts, but obtaining a cashier's check at the buyer's bank is safest.
