How To Set Up A Lottery Syndicate

Setting up your own lottery syndicate is easy and can be done in three simple steps.

First, gather together a group of like-minded lottery buffs. How many is really up to you; syndicates can be as large or as small as you want. Winning syndicates in the past have ranged from small family syndicates to entire company divisions. It doesn't really matter who is in your syndicate, either, provided they are over 18 years old and are serious about winning the lottery.

The next step is to select or nominate a Syndicate Manager. This is the person whose responsibility it will be to collect the money from all syndicate members every week and then play the lottery on their behalf. You will therefore need to ensure your choice of Syndicate Manager is someone who is trustworthy, punctual and very well organised.

Step three, and this is a critical step that sadly many often skip, is to create your lottery syndicate agreement. This document is, in essence, a contract between all syndicate members which defines each member's role, how much is paid, how winnings are shared and so on.

How To Play As A Syndicate With Lottoland

Let's face it, tickets are a hassle – you have to go out to buy them, sometimes when the shops are really busy. They can be lost, stolen or damaged – resulting in lots of stress and tears. Checking numbers is also a pain, and an unnecessary one at that.

Why bother wasting time with any of that when you can just do it all automatically? Playing as a syndicate online with Lottoland is easy. To start your lotto syndicate's road to riches simply follow these three steps:

Once all members have joined and signed the agreement the Syndicate Manager needs to register an account at [Lottoland.co.uk](https://www.lottoland.co.uk)

2

Once the money has been collected from all members the Syndicate Manager then plays the lotto(s) of choice on the syndicate's behalf.

3

Any winnings will then be credited to the Syndicate Manager's Lottoland account, which can then be withdrawn to his/her bank account to be split between each member.
