## Study Participant Form – Information sheet

### Section A – Study participation consent

Information (including personal and sensitive) is being collected as part of *Growing Up in Australia: The Longitudinal Study of Australian Children*, which is conducted as a partnership between the Department of Social Services, the Australian Institute of Family Studies, and the Australian Bureau of Statistics (ABS), with advice provided by a consortium of leading researchers.

The *Growing Up in Australia* study is an ongoing study with information collected using a variety of approaches including paper form, telephone interview, and face to face interview. Information is being used to further the understanding of child and adolescent development and wellbeing, to help the government plan future policies and services.

The ABS is collecting *Growing Up in Australia* study information under the authority of the *Australian Bureau of Statistics Act 1975*. Information is collected from various informants including the study child and their parents and/or guardians. Information collected by the ABS for the *Growing Up in Australia* study is collected on a voluntary basis and will only be used for:

- Statistical purposes; and
- Maintaining contact with study participants for the purposes of the Study.

Data released to researchers or policy makers will be de-identified, and only combined results will be published. All information collected will be kept strictly confidential.

In line with the *Privacy Act 1988* your separate consent will be sought to release personal and sensitive information to any other person or organisation for the purpose of the Study.

If the organisation responsible for future data collection phases of the Study changes, the ABS will be required to disclose your information to that organisation.

Participation in the Study is voluntary and if consent is not provided then *Growing Up in Australia* will no longer collect information from you. You may withdraw from the Study at any time or choose not to take part in some aspects of the Study. 4. I understand that my Centrelink benefits and my personal circumstances data will be confidentialised and stored securely by the Australian Institute of Family Studies (AIFS) **without** a specified date for the destruction of the data as *Growing Up in Australia* is an ongoing study.
5. I understand that my Centrelink benefits and my personal circumstances data will be released to the *Growing Up in Australia* study, from my 16th birthday until the end of the Study, or until I withdraw my consent, whichever occurs first.
6. I understand that my Centrelink benefits data including my personal circumstances data will be provided, stored and analysed only for the purposes of the *Growing Up in Australia* study and will not affect my payments.
7. I understand that this consent form will be retained by the Department of Human Services and the Department of Social Services for the life of the Study as a record of my consent.
8. I understand that an electronic copy of this consent form will be retained by the Australian Bureau of Statistics for the life of the Study as a record of my consent.
9. I understand that my contact details will be used for maintaining contact with me for the purposes of the *Growing Up in Australia* study.
