Supplemental Form: Electricity and Water Use Estimate

What is this form?

In addition to the **Marijuana Business Operating Plan** and **Marijuana Cultivation Plan**, [845-025-1030 \(4\)\(g\)\(B\)](#) requires applicants for a recreational marijuana Producer license to submit a report or estimate of electrical and water usage. Applicants seeking a new Producer license may use this form to provide these estimates to the Commission.

For renewal applications of an existing producer license, applicants are required to submit a report of actual usage.

How do I estimate my electrical usage?

Record your estimates in kilowatt-hours (kWh). To determine how many kWh a piece of equipment uses, take the following steps:

- Determine the wattage of the device by checking manufacturer specifications.
- Multiply this by the number of hours each month the device will be in use to determine watt-hours.
- Divide each month's watt-hours by 1,000 to determine kWh. Round to three decimal places.
- Repeat this for each piece of equipment and total the amounts for each month.

How do I estimate my water usage?

Clearly identify the measurement unit you are using to estimate or report your water usage. If you are using multiple units, you may use additional columns to record that information. If you are using reclaimed water, identify that as a source.

All water used in the cultivation of recreational marijuana must come from sources that are legal under Oregon law, and which are documented, and verifiable. If you are utilizing more sources of water than may be included on this form, you may include that information on additional files uploaded into the online licensing system.

Estimates should assume the business is in full production for each month.

Section 3 – Monthly Electricity Estimates

List the **total** estimated kilowatt-hours (kWh) for **all equipment** that will be used in a given month in the cultivation of recreational marijuana at the proposed premises.

Month and Year: The month and year of the estimate. For example, "Jan 2016"

kWh used: The estimated kWh used by all pieces of equipment used in the cultivation of recreational marijuana requiring power. This does not include power generated on-site.

kWh generated: The estimated total kWh for the month and year that will be generated and used on-site. This includes power from sources such as solar panels or generators.

kWh drawn: The estimated kWh required in excess of the total kWh generated and used on-site. This number should equal **kWh generated** subtracted from **kWh used**.
