Name Based Canadian Criminal Record Verification

Instructions for Applicant:

- A legible Notarized copy of two pieces of identification must be provided before a Name Based Canadian Criminal Record Verification can be completed.
- The first piece of identification must be government-issued and include your full name, date of birth, signature and photo. (e.g. *Driver's License, Passport, Citizenship Card, Permanent Resident Card, Certificate of Indian Status*).
- The second piece of identification should be government-issued and at minimum it must include your full name.
- Fill out Consent Form A. **Note:** *The notary public must witness you signing the consent form.*
- Proceed to the nearest licensed Notary Public with this form, Consent Form A and your two pieces of identification.
- Have the Notary Public verify your identification and fill out **Section 1** and **Section 2** on this form below. Once they have completed this, they must affix their stamp or seal to this form.

Instructions for Notary Public:

- Please provide your contact information in **Section 1** on this form.
- Complete the Identification Verification in **Section 2** on this form. Once completed, affix your seal there.
- Please sign the bottom of Consent Form A, witnessing the candidate's signature.
- Photocopy or scan the applicant's two pieces of identification:
 - The first of which must be government-issued and include the applicant's name, date of birth, signature and photo. (e.g. *Driver's License, Passport, Citizenship Card, Permanent Resident Card, Certificate of Indian Status*).
 - The second should be government -issued, however at minimum it must include the full name of the Applicant.
