1. To set up your booth during Vendor Set-Up Time: Fri, Sept. 22<sup>nd</sup> 9am – 8pm.
2. To keep your maintain your vendor booth the open hours of Tiny Fest Midwest, including Sat., Sept. 23<sup>rd</sup> from 10am-7pm, and Sun., Sept. 24<sup>th</sup> from 10am-6pm. (Opening during Friday night “Prime Time” is optional.) You agree to do so in a reasonable capacity, & without departing prior to the end date and time of the event.
3. To break-down vendor area by Sunday at 10pm.
4. To pay 5% of total sales made at the event to TinyFest Midwest prior to leaving the Jasper County Fairgrounds.
5. To submit at least one logo file and one photograph of one of your products at the time of submitting this form, to be used in promotional activities of Tiny Fest Midwest.
6. To maintain a clean, sanitary and family appropriate area and to behave in a manner appropriate for a family event at the discretion of Tiny Fest Midwest, LLC. By not doing so you agree to modify the display area or to leave the event without fees being refunded.
7. To carry all necessary insurance covering liability and property displayed at the festival.
8. To provide proof of any current licenses and permits necessary and required to prepare, serve and sell food & beverages within the State of Iowa.
9. To obtain any necessary Iowa sales tax permits if on-site sales will occur.
10. Refunds will not be issued for cancellations made less than 7 days prior to the event.
