### RULES & WAIVER OF LIABILITY

**1. ELIGIBILITY:** Challenge is open to all U.S. residents 18 years or older. Employees of Conversation Peace are not eligible to enter. Void where prohibited.

**2. TO TAKE THE CHALLENGE:** *READ CAREFULLY* THIS OFFICIAL CHALLENGE WAIVER, RULES AND ENTRY FORM FOR INCLUDING THE ELIGIBILITY REQUIREMENTS AND WAIVER OF LIABILITY PROVISIONS. All entry forms become the property of Conversation Peace and The Angry Chicken Challenge.

### 3. CHALLENGE RULES:

- Eat 10 ANGRY CHICKEN Wings and a Stuffed Pepper within the allotted time.
- Contestants may eat either sitting or standing in their designated area using hands.
- Contestants will not be allowed to use and/or drink any liquid during the competition.
- Contestants will not be allowed to use any form of a napkin or clothing from their person or anyone else.
- Contestants are not allowed any form of dipping sauces.
- Contestants must wait for the starting signal to begin eating and may not touch any chicken wings prior to the starting signal.
- Contestants must completely eat a chicken wing before beginning to eat another chicken wing and CLEAN BONES as directed by judge at contest table.
- Contestants must stop eating and must promptly place their hands down on the table or at their side at the signal by judge with stop watch.
- Contestants may not put additional chicken wing or wings or portions of chicken wings in their mouths after the ending signal, but will be allowed 15 seconds to swallow any chicken wings already in mouth.
- If a Contestant throws up or regurgitates, he or she will automatically be disqualified.

**4. Judges will be on hand to assure adherence to contest rules**, "no throw up or regurgitating" rule, and to disqualify contestants who fail to adhere to the rules. Winners will be determined by EATING ALL 10 WINGS AND Stuffed Pepper IN THE BASKET IN THE ALLOWED TIME. MUST THAN REMAIN SEATED WITH NO DRINK NO WIPING OF THE HANDS OR MOUTH FOR ANOTHER 5 MINUTE FOR A TOTAL CHALLENGE COMPLETED.

**Grounds for disqualification include:**

- False or incomplete entry form or liability waiver
- Any health risks that could jeopardize the contestant's health or well being
- Under the influence of any substance
- Appearance is deemed inappropriate or unattractive
- Starting prior to the start signal
- \* continuing to eat after the ending signal.
- \* Failure to completely eat a chicken wing before beginning to eat another chicken wing.
- \* Throwing up or regurgitating.
