Rules, Regulations and Conditions for Membership

1) **Fees :**

• Admission : Rs. 7500/-

• Annual : Rs. 2000/- (per member, per year)

- 3) The Agency which seeks membership, shall have to provide proof of doing direct business with atleast 3 (Three) Newspapers being published from Ahmedabad on their credit.
- 4) The Agency shall have to provide a reference, by getting the reference column in the membership form signed by an authorized person from an Agency which is already a member of the AAC, with the name of the Agency.
- 5) The membership of the Agency shall be considered valid only after approval by the executive committee of the AAC. The executive committee reserves all the rights to accept or reject any request for membership.
- 6) The member Agency will be bound by all the rules and regulations of the AAC.
