

Applying for a Reception place

Before completing this application, you should read the information relating to admission to primary school that is published on the Rochdale Council website at www.rochdale.gov.uk/schooladmissions. You should familiarise yourself with the Admission Policies for your preferred schools to see if there is any additional information required to be submitted with your application.

This form must only be used for children who live in the Rochdale Borough. If you live in another area and wish to apply for a Rochdale school you should apply directly to the Local Authority in which you live who will notify Rochdale of your application.

Have you tried applying online?

To register and submit an application online you need a valid, working email address and access to the internet. Internet access is free from any of the libraries across Rochdale borough. If you do not already have an email address, library staff will be able to help you set up a free account.

Why should I apply online?

There are many benefits to applying online:

- You will receive electronic notification of the school place offered on offer day rather than having to wait for a letter;
- It is quick and easy to do;
- You will receive an email confirmation to say that your application has been received, so there is no risk of it getting lost in the post;
- The system is secure and your information is protected;
- You can make amendments at any time up until the closing date of **15 January 2018**;
- You won't need to complete the paper application form;
- It is available 24 hours a day, seven days a week up until the closing date (**15 January 2018**).

Late applications

If you submit your application after 15 January 2018, even by one day, it will be considered to be a late application.

Late applications are processed in a set manner and will not be considered until all the applications that were submitted on-time have been processed.

This means that your child may miss out on an offer of a school place at which he or she would normally have been offered as it is possible that all available places have already been offered to other children.

Terms & Conditions

Before submitting an application, all parents are advised to read the information regarding applying for a primary school place that is published on the School Admissions pages of the Rochdale Council website.

You should also ensure that you read the Admission Policy for each school of your preference and established whether further information (such as a supplementary form or a copy of a baptismal certificate) is required to be provided to support your application.

If you change address, the Local Authority will only take your new address into account where necessary evidence (such as a Tenancy Agreement, exchange of contracts notice or utility bill) has been provided.

If your offer of a school place is obtained on the basis of fraudulent or intentionally misleading information, the place may be withdrawn and offered to someone else.

If it is possible to offer more than one school, a place will be offered at the school that is ranked highest in your order of preferences. If it is not possible to offer any of your preferences, a place will be allocated at the nearest school to your home address with a place available.

Where you are not offered a place at your preferred school, you have the right to appeal this decision to an independent appeal panel.
