Any excess weight will incur additional charges of \$10.00 per kilogram (or part thereof). Excess weight can be either dead weight or cubic weight whichever is the greater. Cubic weight calculation is based on a conversion ratio of 250kg per cubic metre.
- Pick up or delivery requests performed outside normal trading hours Monday to Friday will incur additional charges. For price estimate details please call TNT Customer Service on 13 11 50.
- TNT Express Domestic prepaid products are non-refundable and non-transferable and are subject to the TNT Terms and Conditions of Contract. Extended Warranty is not available for TNT Express Domestic Prepaid products.
