Per BASE ORDER 5100.22, 2-9, **Temporary Registration**. MCO 5100.19 Marine Corps Traffic Safety Program. PMO will issue a temporary restricted pass, **valid for one day**, to motorcycle operators who cannot provide proof of completion of a DOD approved MSF rider course. **This allows an operator access to MCBH only to be register for the next available MSF course at the MCBH Safety Center.** At that time, the MCBH Safety Center will issue a MSF course letter of registration, which authorized the issue of a temporary restricted pass valid through the scheduled last date of the course. At no time shall operators be issued a temporary restricted pass to exceed 30 days.

PRIVACY ACT STATEMENT
