F. TOTAL OF ACCRUED POINTS CLAIMED THROUGH REGISTRATION

REGISTRATION

1. An exhibiting company will receive 1 point for every 9 delegates registered.

3. Points will be calculated for **full paying registrations only**: **Standard fee (early, late, onsite) and Nurse Technician fees**.
