Contact Stephanie with instructions for sending files larger than 5 MB. Onsite program ads must meet this requirement as well as the size specifications in the diagram below.

Artwork for advertisements must be received by Friday, September 6, 2013, to be included in the program.


Other ways to reach attendees!

Conference bag stuffers: Place your items in the official conference bag! CSBA is offering your company the opportunity to have an 8.5" x 11" flier inserted into each attendee bag. Each conference registrant will receive their bag when they check into the conference. This exclusive opportunity will be made available to only four companies based on a first-come, first-serve basis. If accepted, your company must send 3,000 pre-printed copies no later than November 8, 2013.

Program addendum advertising: The program addendum is a separate, supplemental insert that accompanies the conference program. The addendum lists exhibitors and program changes that happen after the program has already been printed. Both the addendum and program are distributed onsite to all conference attendees. Addendum ads must be ¼ page vertical ads noted in the specifications and prices below.
