Your documents will be returned to you by our contracted courier service, and under normal circumstances will be shipped the same business day they are returned to us by INZ. Shipping speed is typically overnight by 10:30 am within the continental U.S., and 2nd day international. However, shipping delays occasionally occur due to unforeseen circumstances such as weather.

Please note that Courier requires a residential or business address for delivery – The Courier cannot deliver to P.O. box addresses.
