___ **CLASS 999 CLOVER KID** Ages 5 – 7. Length of speech, 2 minutes or less - speech does not have to relate to 4-H. This division is not eligible for regional competition.

___ **CLASS 900 JUNIOR DIVISION** Ages 8 – 10 Length of speech, 1 to 3 minutes.
Speech must be original and include 4-H as the major component of the speech.

___ **CLASS 901 INTERMEDIATE DIVISION** Ages 11-13. Length of speech, 3 to 5 minutes.
Speech must be original and include 4-H as the major component of the speech.

___ **CLASS 902 SENIOR DIVISION** Ages 14-18. Length of speech, 5 to 8 minutes.
Speech must be original and include 4-H as the major component of the speech.

Public Service Announcement (PSA)

All PSA's are 60 seconds in length.

Entries for PSA's must include an attached written text of the PSA

PSA's at the county level will be given in person, but a recording must be submitted for entries that advance to the regional level.

The state theme for the 2019 Public Service Announcement is **Inspire Kids to Do** and should be incorporated in the PSA.

Eligibility

- Youth must be currently enrolled in 4-H to participate in the Public Speaking contest.
- Youth in the Junior, Intermediate or Senior divisions may participate in both the Speech and PSA categories.
- Only individuals may compete in the speech or radio PSA competitions – no teams.
- Youth must be selected at their County Public Speaking contest to compete in Regional competition.
- Youth must be selected at their Regional Public Speaking contest to compete in State competition.
- Only Senior Division regional winners in the Speech and PSA categories will advance to the State Public Speaking Contest. Senior Division: 4-H ages 14-18.
- Previous **state winners** in Speech or radio PSA's are no longer eligible to compete in the state contest in the category won at the State contest.

SPEECH

4-H age is age of member on Dec. 31, 2018

CLASS 999 CLOVER KID Ages 5 – 7

Length of speech, 2 minutes or less - speech does not have to relate to 4-H. Not eligible for regional competition.

CLASS 900 JUNIOR DIVISION Ages 8 – 10

Length of speech, 1 to 3 minutes. Speech must be original and include 4-H as the major component of the speech.

CLASS 901 INTERMEDIATE DIVISION Ages 11-13

Length of speech, 3 to 5 minutes. Speech must be original and include 4-H as the major component of the speech.

CLASS 902 SENIOR DIVISION Ages 14-18

Length of speech, 5 to 8 minutes. Speech must be original and include 4-H as the major component of the speech.

Speech Category Rules

- For Junior, intermediate and senior divisions; all speeches must be original and include 4-H as the major component of the speech.
- Clover Kids are allowed to give a simple speech that does not have to relate to 4-H. They may also recite a simple poem they have learned, the 4-H Pledge, etc. that is age appropriate
- 4-H public speakers may not use an old speech written by a sibling, other 4-H member, or anyone else.
- Small note cards are permitted but should not be directly read from.
- Acknowledge the source of information used in the speech. For example, an article from a magazine may be used for reference, but should not be quoted directly unless you tell the audience your source.
- Use of visual aids and props are not allowed.
- Dress appropriately. Do not wear costumes or special effect clothing.
- No team speeches are allowed.

Public Service Announcement (PSA) Category Rules

- All PSA's are 60 seconds in length.
- The state theme for the 2019 Public Service Announcement is **Inspire Kids to Do** and should be incorporated in the PSA.
- All radio PSA's must promote 4-H and be general enough to be used anywhere in Nebraska at any time of the year.

- All 4-H PSA's must include the following tag line within the last ten seconds of the PSA: "Learn more about the University of Nebraska–Lincoln Extension 4-H Youth Development Program at 4h.unl.edu." The tag line is included in the 60 second time limit.
- Sound effects and public domain music may be used. Copyrighted material may not be used.
- All PSA's must be the original work of the presenter. Contestants may not use PSA's written and provided by the state or national staff..
- No team PSA's are allowed.
- PSA's at the county level will be given in person, but a recording must be submitted for entries that advance to the regional level.
- PSA's that are chosen for the Regional contest must be submitted electronically as a .wav or mp3 format along with the Regional registration form.
- Judges will deduct three points from the contestant's score for each 3 seconds under or over the time limit. (Senior division only.)
