Sports Club Registration – FAQ's

Why do Sports Clubs have to be registered to the initiative?

Choose Sport is a referral based grant initiative. This means we only want to deal with organisations we trust and have established reputations within the community. Registration ensures that we can properly keep records and identify the Clubs that will ensure the best use of grant funding for the applicants.

Who has to pay the registration fee and why?

All clubs that are registered to Choose Sport and are not home based clubs at the Papatoetoe Sports Centre must pay the fee. This fee covers the costs of administering the grant initiative, including raising sponsorship, processing applications and liaising with clubs. The fee is payable each season.

Clubs based at the Papatoetoe Sports Centre pay the Trust for this service via capitation fees and are therefore not required to pay the annual fee.

Do we need to register every year?

No. Each registration form covers two years; however the registration fee (if payable) is required annually. The club is obligated to keep their details up to date during this time.

Why is there a maximum of 4 approved referrers?

This is to ensure that the Trust can build a relationship with the referrers and ensures that the grants are helping the right people. It also makes the process easy to manage.

How will grants be paid?

Where membership fees are applied for and approved, the funds will be paid directly to the club being applied for. Where equipment is applied for, the Trust will either provide a voucher or the equipment directly to the referrer.

What happens when a grant is approved?

It is important to understand that the Trusts relationship is with the approved referrer and not the applicant. Therefore we will notify the referrer by email and the club via post. In all cases it is the referrer's obligation to notify the applicant and join them to the club.
