Whereas _____ son/daughter of _____ (thereinafter called students son/daughter/ward of the guarantor and has at the request of the guarantor been selected for admission of JPS,NOIDA for the purpose of receiving education inter alia, on the terms and conditions hereinafter appearing

3. Now it is hereby agreed by and between the parties here to follows.

- a) That in consideration of the student being admitted by the chairman to the Jagran Public School, Noida, for the purpose of the aforesaid education at the request of the guarantor, he, the guarantor, covenants with the Chairman that the student will attend the rules and regulations thereof for the prescribed period, and that he, the guarantor, shall pay to the chairman regularly and promptly and whenever called upon to do so all the fees and other costs as prescribed.
- b) That the Principal can, at any time, in the interest of the school, have the student removed if in the Principal's sole discretion the student has failed to accept the discipline of the school and his/her continued presence is detrimental to the interest of the other students and /or the student fails to come up to the academic standard of his/her class and when detention in the same class would make the student too old for his/her class
- c) That no fees, partial or full will be refunded if the said student is required to leave the school during term time for any reason other than medical grounds acceptable to the Principal.
- d) That the school will not be liable for any damages/ charges on account of injuries, fatal or otherwise, which may be sustained by the student, at any time during his/her stay in the school, while taking part in studies, sports and extra-curricular or any other form of activities of the school, within or outside the school premises.
