



TRAVEL ENDORSEMENT REQUEST

International students and scholars on an F/J visa are required to have their I-20/DS-2019 endorsed for travel to re-enter the U.S. A Travel Endorsement is **valid for one year for continuing students and scholars and for 6 months for students on Optional Practical Training (OPT) or Academic Training.**

In order to re-enter the country, you will need to have a valid I-20/DS-2019, passport, and F/J visa upon re-entry of the country. It is also recommended that students enroll for the following semester before travel, if possible.

For international students or scholars traveling outside of the U.S., please submit original I-20/DS-2019 with this COMPLETED Travel Endorsement Request form.
