

## **UNDERTAKING**

The University management reserves the right to add, alter or amend any of the rules and the same shall be binding on the parents, guardian and students

1. **Being aware that 60% attendance in all courses is obligatory for appearing in the Internal University examination, I undertake to be punctual & regular in all the theory & practical classes the university reserves the right to debar me from the internal/university examination if I fall short of attendance criteria.**
2. I undertake to complete and submit all assignments in time for regular assessment by the teacher(s).
3. I also undertake to strictly follow the instructions as laid by the University regarding internal tests & evaluation. It is solely my responsibility to appear in all the internal examination, incase I don't appear in these tests I shall not be allowed to take the university examination.
4. I undertake to follow and maintain proper decorum and discipline in the campus, in classrooms, laboratories/ workshops and library. Outside the campus also, I shall show dignified and exemplary behaviour in tune with civilized society that I belong to.
5. I shall extend courtesies to all the teaching and non-teaching staff of the university as well as to my senior students. In case of any difficulty being faced, I shall approach for guidance of the tutor/proctor/HOD/ Dean/Principal/Director/President and shall not indulge in groupies etc. which does not fit into professional ethos of the university.
