



## Avant Garde Academy Volunteer Release and Waiver of Liability Form

This Release and Waiver of Liability ("Release") executed on \_\_\_\_\_ (date) by \_\_\_\_\_ (Name of Volunteer, referred to herein as "Volunteer") releases Eagle Arts Academy, Inc, a nonprofit corporation organized and existing under the laws of the State of Florida ("Charter School") and each of its directors, officers, employees, and agents and their respective successors and assigns. The Volunteer desires to provide volunteer services for the Charter School to engage in activities related to serving as a volunteer.

Volunteer understands that the scope of Volunteer's relationship with the Charter School is limited to a volunteer position and that no compensation is expected in return for services provided by Volunteer. Volunteer is not an employee or agent of the charter school; that the Charter School will not provide any benefits traditionally associated with employment to Volunteer; and that Volunteer is responsible for his/her own insurance coverage in the event of personal injury or illness as a result of Volunteer's services to the school.

1. Waiver and Release: I, the Volunteer, release and forever discharge and hold harmless Charter School and each of its directors, officers, employees, agents, and their respective successors and assigns ("Released Parties") from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from the volunteer services I provide the Release Parties.. I understand and acknowledge that this Release discharges Charter School from any liability or claim that I may have against Released Parties with respect to bodily injury, personal injury, illness, death, or property damage whether to myself or my property, or to others or the property of other, that may result from the volunteer services I provide to the Charter School or occurring while I am providing volunteer services.
2. Insurance: Further I understand that the Released Parties do not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health or disability benefits or insurance of any nature in the event of my injury, illness, death or damage to my property. I expressly waive any such claim for compensation or liability on the part of the Released Parties beyond what may be offered freely by the Charter School in the event of such injury or medical expenses incurred by me.
3. Medical Treatment: I hereby Release and forever discharge the Released Parties from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my tenure as a volunteer with the Charter School.
4. Assumption of Risk: I understand that the services I provide to the Charter School may include activities that may be hazardous to me including, but not limited to



campus clean-up, and may involve inherently dangerous activities. As a volunteer, I hereby expressly assume the risk of injury or harm from these activities and release the Released Parties from all liability for injury, illness, death or property damage, either to myself or my property or to others or the property of others, resulting from the services I provide as a volunteer or occurring while I am providing volunteer services.

5. Photographic Release: I grant and convey to the Charter School all right, title, and interests in any and all photographs, images, video, or audio recordings of me or my likeness or voice made by Charter School in connection with my providing volunteer services to Charter School. I also consent to the photographing, videotaping, or audio recording of me by Charter School in connection with my providing volunteer services to Charter School.
  
6. Other: As a volunteer, I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Florida and that this Release shall be governed by and interpreted in accordance with the laws of the State of Florida. I agree that in the event that any clause or provision of this Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected.
