AUGUST 2013 ENROLLMENT CONFIRMATION FORM REGULAR DECISION OPTION

1. Having been offered admission to Elon University School of Law through its Regular Decision option, the candidate must confirm his or her intention to enroll in August 2013 by forwarding the required enrollment confirmations to the School of Law.
2. A completed Enrollment Confirmation Form must be received by the School of Law on or before April 1, 2013. An initial non-refundable \$200 confirmation deposit must accompany this Confirmation Form. A second non-refundable \$400 confirmation deposit is due on or before June 1, 2013.
3. The confirmation deposits will be credited toward the student's tuition upon enrollment at Elon. These deposits will be refunded only if the applicant is called into the Armed Services prior to the opening of school in August.
4. The applicant's deposits may be submitted by mail (check or money order). The deposits may also be submitted online at www.elon.edu/admissions/deposit using the username and password provided in the acceptance letter.
5. Tuition for the 2013-2014 has not been set at this time. Tuition for the 2012-2013 academic year was \$36,100.00. One half of tuition and fees will be payable each semester. A complete payment and refund schedule is available on the schools' web site.
6. In accordance with American Bar Association Standards for Approval of Law Schools, no student should engage in outside employment without express permission of the Dean.
7. If the applicant is a candidate for his or her undergraduate degree in May or June 2013, or if the transcript now filed with the law school does not show the award of an undergraduate degree, matriculation in August 2013 is conditioned upon the prior filing of a final transcript showing the award of an undergraduate degree. Acceptance of an applicant receiving special acceptance upon completion of three-fourths of the work required for a bachelor's degree is likewise conditioned upon the prior filing of final transcripts.
8. The applicant's matriculation in August 2013 is also contingent upon the submission of a completed Dean's Certification Form from each post-secondary institution (community college, undergraduate, graduate or professional) that has awarded or is expected to award the applicant any degree and any post-secondary institution where the applicant was subject to any disciplinary actions including, but not limited to, those for academic and conduct reasons. These forms must be completed by the institutions and returned to the School of Law by August 1, 2013.
9. The School of Law reserves the right to rescind its offer of admission and award the applicant's position in the fall class to another applicant should the applicant fail to submit the confirmation form and deposit to the school by April 1, 2013.
