

## Athlete Evaluation Consent Form

I, \_\_\_\_\_ agree to undergo the Athlete Evaluation Process as outlined in the UCI Classification Rules and Regulations.

1. I understand that this Athlete Evaluation may require me to participate in sport-like exercises and activities which may include me being observed whilst competing. I understand that there is a risk of injury in participating in exercises and activities. I confirm that I am healthy enough to participate in the Athlete Evaluation.
2. I understand that I have to comply with the requests made by both the UCI and the Classification Panel. This includes providing sufficient documentation to determine whether I comply with the eligibility requirements for para-cycling. I also understand that if I fail to comply with any such request then Athlete Evaluation may be suspended without a Sport Class being allocated to me.
3. I understand that the Athlete Evaluation Process requires me to give my best effort, and that any Intentional Misrepresentation of my skills, abilities and/ or the degree of my Impairment during Athlete Evaluation may result in the consequences set out at article 16.4.032 of the UCI Regulations (provisional suspension, disciplinary action, disqualification, ineligibility for Athlete Evaluation).
4. I understand that Athlete Evaluation is a judgment process and I agree to abide by the decision of the Classification Panel. If I do not agree with the decision of the Classification Panel, I agree to abide by the protest and/or appeal process as defined in Part Six: Protests, and Part 10: Appeals, of the UCI Classification Rules and Regulations.

I understand that I may be photographed and/or audio or visual recorded by UCI staff and officials (including classifiers) during Athlete Evaluation, including my activity on and off the field of play. Recordings of any nature of Athlete Evaluation by persons or entities other than UCI staff and officials (including classifiers) are strictly prohibited.

5. My personal data, including but not limited to my Sport Class, Sport Class Status and relevant medical information that has not already been collected by the UCI (Personal Data), may be collected by the UCI and/or my National Paralympic Committee (NPC) and/or my National Federation (NF). The UCI shall store my Personal Data (including transfers to or storage on the UCI's owned or contracted servers). The UCI may share my Personal Data with my NPC, my NF, UCI classifiers, the UCI Medical Director and/or the UCI Medical Commission, for the purposes of and to the extent necessary in relation to Athlete Evaluation and facilitating my participation in UCI Competitions.
6. My Personal Data will be transferred to the UCI Medical Commission (or designated representative) if the UCI or the Classification Panel, upon review of Medical Diagnostic Information or through any observation during Athlete Evaluation, is of the view that I may have a health condition which could be adversely impacted by my participation in the sport of para-cycling for the purposes of assessing that risk and determining the appropriate outcome.
7. My name, gender, year of birth, country, Sport Class and Sport Class Status may be published by the UCI and shared with my NPC, NF and competition organisers.

**Additional Explanation (Consent):****8. Use of Personal Data for Research Purposes**

- I wish to assist the UCI in developing the Classification system and therefore allow my Personal Data, including video material recorded during training and competition, to be used for research and educational purposes by the UCI in perpetuity, provided such Personal Data is anonymised prior to any publication.

Providing or not providing this consent does not affect the fulfilment of this Athlete Evaluation Agreement Form as a whole. If consent for research purposes is not provided, Personal Data will not be used for this purpose. If consent is provided, it can be withdrawn at any time by contacting the UCI at: [data.protection@uci.ch](mailto:data.protection@uci.ch).

**9. Release of Claims**

I hereby release the UCI and its respective executive members, directors, officers, employees, volunteers, contractors or agents, from any liability (to the extent permitted by law) for any loss, injury or damage suffered by me in relation to the collection of my Personal Data by the UCI or NF and/or my participation in Athlete Evaluation.

**Access to Personal Data**

I understand that I have a right to access and correct the Personal Data that the UCI holds about me under data protection law by contacting the UCI ([data.protection@uci.ch](mailto:data.protection@uci.ch)). I also understand that my eligibility to participate in the sport of para-cycling is contingent on my voluntary participation in Athlete Evaluation so that a Sport Class can be allocated to me. I also understand that I may withdraw my agreement to the UCI processing and storing my Personal Data at any time. I further understand that the withdrawal of my agreement to the processing and storing of my Personal Data may result in me being ineligible to participate in the sport of para-cycling.
