

ORDINANCE NO. 08-036

**ORDINANCE AMENDING CHAPTER 8, ARTICLE 25 OF
THE MUNICIPAL CODE--PREPARED FOOD SALES TAX**

WHEREAS, Section 6(a) of Article VII of the 1970 Constitution of the State of Illinois provides that any municipality which has a population of more than 25,000 is a home rule unit, and the Village of Bolingbrook, Will and DuPage counties, Illinois, with a population in excess of 25,000 is, therefore, a home rule unit and, pursuant to the provisions of said Section 6(a) of Article VII, may exercise any power and perform any function pertaining to its government and affairs, including, but not limited to, the power to tax and to incur debt; and

WHEREAS, the Mayor and Board of Trustees believe and hereby declare that it is in the best interests of the Village and its residents to amend the provisions of the Municipal Code of the Village relating to the tax levied and imposed upon the sale of prepared food within the Village;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF TRUSTEES OF THE VILLAGE OF BOLINGBROOK, WILL AND DU PAGE COUNTIES, ILLINOIS, IN THE EXERCISE OF ITS HOME RULE POWERS, AS FOLLOWS:

SECTION ONE: The foregoing recitals are hereby incorporated in this Section One as if said recitals were fully set forth herein.

SECTION TWO: Section 8-2502 of Chapter 8, Article 25 of the Municipal Code of the Village of Bolingbrook shall be and is hereby amended in its entirety so that said Section 8-2502 shall hereafter be and read as follows:

Section 8-2502. IMPOSITION OF TAX. There is hereby levied and imposed upon the privilege of purchasing prepared food at any retail food establishment in the Village a tax of one and one half percent (1.5%) of the purchase price, in addition to any other tax charged for such prepared food.

SECTION THREE: The remainder of Chapter 8, Article 25 which is not expressly amended herein is hereby ratified and affirmed and shall remain in full force and effect.

SECTION FOUR: Any policy, resolution or ordinance of the Village which conflicts with the provisions of this Ordinance is, to the extent of such conflict, expressly repealed.

SECTION FIVE: This ordinance shall be in full force and effect from and after its passage, approval and publication in the manner provided by law.


I further certify that on April 22, 2008 the Corporate Authorities of such municipality passed and approved Ordinance No. 08-036 entitled:
